Students in Youth Life Learning Centers participate in structured academic enrichment and one-on-one mentoring after school and six weeks of summer instruction. 1) Academic Support: YLFR Learning Centers are staffed by certified teachers in order to provide quality, individualized instruction, and ongoing evaluation of student progress. 2) One-on-one mentoring: individualized lesson plans are implemented by committed volunteer mentors during Learning Center hours throughout the week, allowing each child to receive personal attention and build trust with a caring adult. 3) character development: students focus on meeting high expectations for their social and behavioral development as they grow into responsible members of their communities. 4) Long-term commitment: a unique and vital element of the YLFR model is to invest in children from a young age and stick with them through graduation from high school.
